1. Release and Waiver. VOLUNTEER AND VENDORS UNDERSTANDS THAT THIS RELEASE DISCHARGES HOLIDAY TRAIN LIGHTS FROM ANY LIABILITY OR CLAIM THAT THE VOLUNTEER MAY HAVE AGAINST HOLIDAY TRAIN LIGHTS WITH RESPECT TO ANY BODILY INJURY, PERSONAL INJURY, ILLNESS, DEATH, OR PROPERTY DAMAGE THAT MAY RESULT FROM VOLUNTEER'S ACTIVITIES WITH HOLIDAY TRAIN LIGHTS, WHETHER CAUSED BY THE NEGLIGENCE OF HOLIDAY TRAIN LIGHTS OR ITS OFFICERS, DIRECTORS, EMPLOYEES, OR AGENTS OR OTHERWISE. VOLUNTEER ALSO UNDERSTANDS THAT HOLIDAY TRAIN LIGHTS DOES NOT ASSUME ANY RESPONSIBILITY FOR OR OBLIGATION TO PROVIDE FINANCIAL ASSISTANCE OR OTHER ASSISTANCE, INCLUDING BUT NOT LIMITED TO MEDICAL, HEALTH, OR DISABILITY INSURANCE IN THE EVENT OF INJURY OR ILLNESS.



2. Medical Treatment. Volunteer/Vendor does hereby release and forever discharge Holiday Train Lights from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteer's Activities with Holiday Train Lights.

3. Assumption of the Risk. The Volunteer/Vendor understands that the Activities may involve work that may be hazardous to the Volunteer, including, but not limited to, Crowd Control, being near, around or on scaled trains, work near or in a parking area and work in or around live animals. Volunteer hereby expressly and specifically assumes the risk of injury or harm in the Activities, and releases Holiday Train Lights from all liability for injury, illness, death, or property damage resulting from the Activities.

4. Insurance. The Volunteer/Vendor understands that, except as otherwise agreed to by Holiday Train Lights in writing, Holiday Train Lights does not carry or maintain health, medical, or disability insurance coverage for any Volunteer/Vendor. Each Volunteer/Vendor is expected and encouraged to obtain his or her own medical or health insurance coverage.

5. Photographic Release. Volunteer does hereby grant and convey unto Holiday Train Lights all right, title, and interest in any and all photographic images and video or audio recordings made by Holiday Train Lights during the Volunteer's/Vendor's Activities with Holiday Train Lights, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

6. Other. Volunteer and/or Vendor expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Florida, and that this Release shall be governed by and interpreted in accordance with the laws of the State of Florida. Volunteer and/or Vendor also agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the December 2018 remaining provisions of this Release which shall continue to be enforceable.
